All of Sacred Wind's new broadband loop carrier cabinets are installed and operating, having used RUS loan money, and broadband services at a minimum of 768 Mbps are being made available to over 90 percent of Sacred Wind's current customers who have been recently transferred from Qwest's switching system to Sacred Wind's. Sacred Wind will be completing by December 15, 2009 its last tower and fixed wireless installations in this area and will be able to provide broadband to ALL of Sacred Wind's new customers who do not have access currently to any home-based communications services. As Sacred Wind completes its fiber optic expansion to its fixed wireless systems, it will be able to increase upload and download speeds to above 3 Mbps per household. The precise number of households, served and today unserved are withheld for reasons of confidentiality.
