unmatched, experience successfully managing the usTLD space. The operational team reports to the Vice President of Registry Services who reports directly to NeuStar's Executive Oversight team.


Ongoing Operations Team

This stability is crucial as it permits NeuStar to continue to




Exhibit A-2. NeuStar's Executive Oversight Committee ensures the requisite resources — human and capital — are committed to the continued success of usTLD.



Jeffrey Ganek, President and Chief Executive Officer

Mr. Ganek has served as Chairman of the Board and Chief Executive Officer at NeuStar since December 1999. Prior to joining NeuStar, he was Senior Vice President and Managing Director of Communications Industry Services (CIS) at Lockheed Martin, an advanced technology company. CIS, which was divested from Lockheed Martin in 1999 to form NeuStar, provided clearinghouse services to the telecommunications industry. Mr. Ganek has more than 20 years of experience in telecommunications, and has held senior management positions in operations, finance, marketing, and business development. Mr. Ganek holds a bachelor's degree in economics and a master's degree in public policy and management, both from Carnegie Mellon University.

Lawrence Bouman, Chief Operating Officer

Mr. Bouman is NeuStar's Chief Operating Officer. A distinguished executive with an impressive record in managing fast-growing communications infrastructure companies, Mr. Bouman prefaced his current NeuStar appointment by serving as a senior advisor to NeuStar management since 1999, focusing on operations and management of growth.
