REASON(S) FOR AMENDMENT

The Department approves the proposed policy change to allow EDUCAUSE to expand eligibility of .edu registrations for certain associations/non-profits entities. Specifically, the .EDU eligible institutions are associations/non-profits whose vast majority of members are colleges, universities, and other educational organizations, provided that at least 75 percent of their institutional members are themselves eligible for an .EDU domain. Entities that meet these requirements are now eligible for one .EDU domain. In addition, update the Grant Specialist name and correct the Federal share cost amount; this cooperative agreement is performed at no cost to the Federal government, per email received from Elizabeth B. Bacon dated March 04, 2014. All other .EDU domain eligibility requirements remain unchanged.
