## SPECIAL AWARD CONDITIONS

Award Number EDU.01

Amendment Number Six (6)

1. The following policy rules are approved to foreclose any opportunity for institutions to transfer their .edu name to any other entity:

(1) Registrant must be an eligible U.S. educational institution under current EDUCAUSE policy or an institution that was permitted to register a name under terms established by prior managers of the .EDU domain ("grandfathered institution"). Registrants may only register one name per eligible institution. Registrants with more than one name registered under prior managers of the .EDU domain ("grandfathered names") may retain those grandfathered names at this time, however, such Registrants must otherwise comply with this policy with respect to any new registrations.

(2) Registrants may only register the institution name as a domain name in .EDU (e.g., REGISTRANT.EDU). No generic names or descriptions may be registered.

(3) No Registrant of a name in the .EDU domain may sell, trade, lend, lease, assign, or otherwise transfer a .EDU name to any other organization. This restriction is not intended to limit a Registrant's ability to designate an external organization as being responsible for administrative or technical operation of its .EDU name.

(4) No name registered in the .EDU domain may be intentionally deployed to identify any organization other than the Registrant itself. This restriction is not intended to limit in any way the selection by a Registrant of third-level (or higher-level) names or of organizations to which the third or higher-level names may refer. Thus, the name REGISTRANT.EDU must be used to identify the Registrant, while ANYNAME.REGISTRANT.EDU has no such limitation. However, Registrants using grandfathered names not in accordance with this policy may continue to do so at this time.

2. If EDUCAUSE becomes aware of a violation of these Policies, EDUCAUSE will notify the Registrant in writing and, if the violation is not corrected within 45 days, will remove the registration of the such .EDU name, taking the necessary technical steps to return the name to the pool of available names as soon as practicable. Violations will be noted and dealt with regardless of how long such violations were in place prior to notification.

3. EDUCAUSE will conduct a study of .EDU names that are currently not in compliance with these Policies, including grandfathered names. Such study should include an examination of how many names in the current .EDU registry fail to comply with these Policies and recommendations with respect to bringing such registrations into compliance. EDUCAUSE shall submit this study to the Federal Program Officer no later than six (6) months from the date of execution of this amendment by the Grants Officer.
