REASON(S) FOR AMENDMENT

1. To approve the change in eligibility rules for institutions applying for the .edu top level domain names, in accordance with EDUCAUSE's November 27, 2002, letter which is incorporated into the award by reference. The following language change is approved:

Eligibility for a .edu domain is limited to post-secondary institutions that are institutionally accredited by an accrediting agency appearing on the U.S. Department of Education's list of "Nationally Recognized Accrediting Agencies" at <http://www.ed.gov/offices/OPE/accreditation/natl agencies.html>. (Note that "Nationally Recognized Accrediting Agencies" includes both "Regional Institutional Accrediting Agencies" and "National Institutional and Specialized Accrediting Bodies.")

2. EDUCAUSE's plan for charging a fee to name holders for the management of the names in .edu is not approved at this time.

This Amendment approved by the Grants Officer is issued in triplicate and constitutes an obligation of Federal funding. By signing the three documents, the Recipient agrees to comply with the Amendment provisions checked below and attached, as well as previous provisions incorporated into the Award. Upon acceptance by the Recipient, two signed Amendment documents shall be returned to the Grants Officer and the third document shall be retained by the Recipient. If not signed and returned without modification by the Recipient within 30 days of receipt, the Grants Officer may unilaterally terminate this Amendment.
