Outreach and Education

Governance Meetings – Five governance meetings were held in this reporting period. The quarterly Integrated Public Safety Commission (IPSC) meeting and the Statewide Interoperability Executive Committee (SIEC) meeting were both held on December 17th. Three SIEC monthly conference calls were also held. Details of the SLIGP were provided to commissioners/representatives at both meetings, as well as additional information regarding FirstNet/broadband activities.

Stakeholder Meetings - Project staff attended/presented information to three stakeholder groups: 1. The Indiana APCO Public Safety Symposium, October 2 (250 attendees); 2. The Indiana Telecommunicators Conference on December 5 (75 attendees); and a meeting with NG911 executive staff on November 11 (four attendees).

Outreach and Education -Officially sanctioned FirstNet outreach materials are still not available, so the number of "pages" distributed remains at zero. Progress has been made in establishing a website. Project staff is working with the Indiana Department of Technology (IOT) to set up the framework for the site.

Other Activities – Project staff continues to meet weekly to discuss broadband issues, strategy and logistics. The two chairs of the Indiana Broadband Working Group (Indiana Dept. of Homeland Security Executive Director John Hill and Indiana Chief Information Officer Paul Baltzell) attend these meetings at least once a month.

Project Team attended all NCSWIC and FirstNet/NTIA webinars.

The two Outreach Coordinator positions were posted on the state jobs board in December. More than sixty (60) applications were received. Interviews/selection to be held in January.

Due to a delay in the state approval process, the two outreach coordinators have not been hired. The job has been posted and interviews scheduled. This impacts the rollout of our outreach efforts.

Most of the staff activity this quarter has been dominated by SLIGP procedures and preparation for hiring staff. We originally planned to plan for/hold a kickoff meeting in January, but project co-chairs decided there was too little information to share at this point and were reluctant to have stakeholders take the time to drive into Indianapolis without more substantial details to share. We are looking to provide webinars as a method for communicating information.

11d. Describe any success stories or best practices you have identified. Please be as specific as possible.

We feel that our existing strong governance structure takes some of the pressure off of SLIGP Phase 1 requirements. Additionally, our heavy investments in CASM will certainly yield results during the planning process.
