# Mandate and problem statement

IoT users and consumers have difficulty determining the extent of security support for an IoT device without clear information regarding the manufacturer's' commitments to security patching and updatability.

This Working Group #3 will identify the critical elements of information that should be communicated to IoT users and consumers regarding device updatability, and will explore potential means of clearly communicating that information.

# Baseline inputs and deliberative points

## Baseline inputs

- Government (FTC, DHS)
  - Third party (OTA, Five Star Framework)
  - Companies (Microsoft)
- Identification of several common points related to updatability

## Deliberative points

- Staying within scope while recognizing that updatability not the cure-all
- Balancing clarity of guidance with voluntary, non-prescriptive nature

# Draft of key elements

- 1. A description of whether the device can receive security updates.**
- 2. A summary of how the device receives security updates.**
- 3. If known, describe the expected time after which the device may no longer receive security updates.**

# Draft of additional considerations

- 4. Identify where consumers may obtain more information about relevant security policies.**
- 5. Describe how the manufacturer notifies purchasers of security updates.**
- 6. Describe what happens when the device no longer receives security update support.**
- 7. Describe how the manufacturer secures updates, or explain that the process is reasonably secure.**
- 8. Describe steps consumers and end users can and should take to help securely use IoT devices.**
