<p>Milestone activities: Baker &amp; KSP continued to send and receive the FirstNet outreach packets to stakeholders and public safety groups in each of 120 counties. i.e. local and state law enforcement, local fire dept's, local emergency management &amp; public officials, etc. This packet included OEC maps for projected FirstNet coverage and other information about FirstNet. We received 54 completed packets in Q6. Three Monthly Public Safety Working Group meetings held as scheduled. KY has scheduled and is working with FirstNet on the initial consultation for January 28<sup>th</sup>, 2015.</p>
