The program is ramping up slowly as program staff evaluates the allowable activities and coordinates with North Carolina Emergency Management for support. An MOU is being reviewed for NCEM to support NC DIT on SLIGP2 efforts. The SIEC (Governance body) did not meet this quarter due to a change in the SWIC. The SPOC position dedicated 53% of his work to SLIGP2 activities. A lot of work was performed by the SPOC in coordination with AT&T and State Procurement in order to get the contract for FirstNet service finalized.


