An Award Action Request (AAR) will be submitted next quarter to request a buget adjustment to move the funding from the Sub-contractual and Other categories to the Personnel Salaries and Personnel Fringe Benefits categories. This adjustment will allow funding for a new IT Manager II term position. This positon will be responsible for the outreach and education functions of the grant and will assit the Cabinet Secretary on grant related functions. The encumbent of this position will have an IT background, with a sustantial technical and managerial experience. A new Baseline Report will be submitted with the AAR along with the Budget Narative, SF-424A, and revised detailed budget spreadsheet.

DolT currently hosts a website for the New Mexico public safety communities with the goal to provide local, state, and tribal entities an understanding of the National Public Safety Broadband Network (NPSBN). This website should offer first responders and administrators an overview and update of the NPSBN and address specific broadband communication challenges that support emergency services. The current website is adequate, however as it exists today there is a lost opportunity to further reach first responders, deliver a path to education and knowledge, and offer a venue to provide feedback. To achieve these goals, the website will be enhanced by the web designer Xynergy. The assessment of other states' sites assisted in the determination that our site required improvement. The website allows the state to present their progress of their project not only to the stakeholders, but NTIA and FirstNet.

11d. Describe any success stories or best practices you have identified. Please be as specific as possible.

The Department of Information Technology (DoIT) deployed the new Public Safety Broadband Communication system at the 2016 Zozobra. This event had over 57,800 attendess with 300 plus first responders. This is the same system DoIT successfully deployed last year at the New Mexico State Fair and the International Balloon Fiesta and re-deployed at these same events this year. These three technology showcases allowed the first responders to sample the devices and test the apps using real life scenarios. The most significant impact at these events was reuniting lost kids with their families in minutes. These events are saturated with first responders and worked well for distributing material on the National Public Safety Broadband Network (NPSBN) and FirstNet. Having first responders see the system provide realtime data at their fingertips contributes to the adoption of the NPSBN. Technology showcases are a great tool for bringing the technology to the stakeholders.
