In this quarter, the New Mexico SLIGP focused on the draft state plan as provided by FirstNet. July saw key meetings being held by stakeholder members who were placed on the review committee and read through the Plan and provided comments and dialogue. Included in this team were representatives of State, County, 911, Public Regulation Commission, Indian Affairs Division and Navajo Technical University and the Navajo Governmental Council. Also included were representatives of Guam and Arizona. Issues of concern focused on coverage, particularly in the rural areas and along the border. During this time, FN also ramped up its efforts with the tribes in NM and other locations and the State participated with FN reps. In anticipation of the Governor's "intent" to opt-in, the team corresponded frequently and heard broad converstions from other states regarding their challenges. All discussions were strategic and intended to best inform the SPOC in his recommendation to the Governor. Upon the Governor's written letter of intent, the State SPOC and Deputy SPOC reached out to the team to ensure they were thanked and acknowledged before the announcement was public. August saw continued work with state and local providers of security at major state events: Zozobra, State Fair and planning for the Balloon Fiesta. Documentation of the planning and engagement of DoIT is important to the development of effective governance. Past governance efforts have been reviewed and, with the deployment of the FN/ATT network, a new govenrance strategy is under development. The team is examining all the key elements of governance to ensure all components are considered. To that end, participation at the APCO conference and meetings with other states wherein their governance entities are very diverse, help inform the strategy for the state going forward. GIS is also an important element of public safety for boots on the ground" and NG 911 efforts. To that end, the Deputy SPOC and GIS broadband liaison attended the national GIS conference to discuss with states and tribes in attendance the importance of being a voice at the table for planning. NM has been ahead of the curve with that strategy. The Deputy SPOC co-presented at the State 911 conference and updated attendees on the status of FN. The Deputy SPOC was also a presenter at the State Homeland Security Conference which engaged over 300 emergency management professionals. The Secretary/SPOC was also a keynote speaker on the second day of the conference and shared the intent of FN, it's status and how the state sees public safety communications as an important element in the effective protection of NM citizens. As a result, Deputy SPOC was asked to work with one of the rural regions which had recently experienced an active shooter resulting in fatalities. There is planning to meet with cities and towns in that region of the state in November. DolT was also asked to share its state plan with the State of AZ and the territory of Guam, which was approved. The Deputy SPOC participated at a Mayors' Summit co-sponsored by ATT. She added clarification as to the implications of the Intent to Opt In decision by the Governor and liaised with mayors for further presentations. Meetings were also held with the State Procurement Office regarding the status of mechanisms which would allow purchase of FN/ATT services by NM stakeholders. This issue remains unclear at some level, even though ATT reports that it has had its FN services approved to be added to GSA and NASPO purchasing vehicles; there remain questions which are being explored to ensure stakeholder questions concerns can clearly be answered. The SPOC and his team met multiple times with the Dept of Indian Affairs to develop a better strategy for reaching the diverse tribes. The Navajo Nation has been proactive and through work of the FN and relationships developed by the SPOC, Deputy SPOC and the Dept's Indian Affairs liaison, we were invited to participate and speak at the Navajo Council meeting in Flagstaff, AZ. Representatives of the Navaio Nation and counties in AZ that adjoin the nation were also present. The SPOC presented on the NM strategy and introduced his staff, both of whom were familiar to participants.

Challenges/Obstacles:

The Governor's intent to opt-in has been a confusing concept for stakeholders. It has been important for stakeholder community to understand the final opt-in decision means FN/ATT can build the network, that the services are not free and devices are not provided. While the NPSBN technology is important, it is not well understood. Therefore, governance, good governance with a clear focus must be established. Tribal outreach remains both a priority and a challenge. With the GAO and the Congressional oversight committee putting an emphasis on FN understanding tribal sovereignty and outreach, FN/ATT must work more collaboratively on this engagement. As state and local entities are being approached by ATT, it has been confusing for some as there is a belief that the State is the sponsor. While that may be true, that is not formal until a governance mechanism is established; the state should take that lead as the enterprise technology provide in the state. The relationships among the key partners must still be clarified and the state must be clarified and the state must be clarified so the message is clear and, if another vendor is able to provide "similar" services, the message is of utmost importance. FirstNet/ATT are doing their own outreach for sales. The state is not always aware of groups with whom they are meeting which is causing some confusion.
