Executive Summary	Two transportable microwave video surveillance systems assigned to the Fort Worth, TX, HUD-OIG office are the last remaining microwave video surveillance systems used by HUD. All previous microwave video surveillance systems were replaced with Internet Protocol video surveillance systems during the 1710-1755 MHz relocation initiative. It is the intention of HUD-OIG to replace the antiquated microwave equipment in the Fort Worth, TX Office with Internet Protocol Systems that will not rely on the 1755-1780 MHz Band for support within one month following completion of the auction (estimated for Mar 2015). HUD-OIG has no other equipment Department wide operating in the 1755-1780 MHz Band.
