Distance Learning and Telemedicine Program

Bringing the World to Rural America

The Distance Learning and Telemedicine (DLT) Program provides both educational and healthcare opportunities in rural communities through grants that finance advanced telecommunications technologies. The focus is on using the unique capabilities of telecommunications to connect rural areas to each other and to the world, thus overcoming the effects of remoteness and low population density. DLT, which began in 1993, has funded more than 1,400 projects totaling \$512 million.

Projects funded by these grants have allowed rural residents to benefit from healthcare services provided to rural clinics and hospitals through broadband infrastructure. Students are now able to take advanced and specialized courses without having to travel long distances to attend classes.

DLT Grant Program Features

DLT grant applications are accepted annually through a competitive process. The open season for applications is announced through a Notice of Funding Availability (NOFA) in the *Federal Register*. Applicants are required to provide a minimum of 15 percent in matching funds. Grant minimum and maximum award amounts are specified in the NOFA. Distance learning means a curriculum delivered via telecommunications and stresses the connection of students and teachers at remote sites. **Telemedicine** means the delivery of health care from medical professionals at one site to patients at other sites via telecommunications. Telemedicine shows benefit to rural residents either in reduced travel or access to services.

Eligible Applicants:

Corporations or partnerships; tribal nations or organizations; State or local units of government; consortiums or other legal entities; and for-profit or not-for-profit entities able to contract with the U.S. Government. No individuals or sole-proprietorships are eligible;

 Operate a rural community facility, or deliver DLT services to entities that operate a rural community facility or to residents of rural areas at rates calculated to ensure that the benefit of the financial assistance passes through to such entities or to residents of rural areas.

Eligible Equipment:

This list is not exhaustive and does not convey automatic eligibility. To be eligible in full, items must be primarily for DLT eligible purposes. Eligible equipment includes:

- Audio and video equipment;
- Computer hardware and software;
- Computer network components;
- Terminal equipment;
- Data terminal equipment;
- Interactive audio/video equipment;
- Original Equipment Manufacturer (OEM) or OEMauthorized warranties on eligible equipment up to the 3-year life of the grant; and
- Inside wiring.

Competitive Scoring Criteria:

A total score of 220 points is possible through the following 8 scoring categories:

- 1. Rurality (population density) 45 points
- National School Lunch Program (economic need) –
 35 points
- 3. Leveraging (matching funds) 35 points
- 4. USDA-Designated Empowerment Zones 10 points
- Additional National School Lunch Program 10 points
- 6. Need for Services and Project Benefits 45 points
- 7. Innovativeness 15 points
- 8. Cost Effectiveness 35 points
