Narrative description for each activity reported in Question 11 for this quarter; any challenges or obstacles encountered and mitigation strategies you have employed; planned major activities for the next quarter; and any additional areiest This guarter we closed down SLIGP 1.0 and started SLIGP 2.0. On 3/09/18 – our Bureau of Information and Telecommunications (BIT) CIO signed the SLIGP 2.0 Grant #46-10-S18046 to allow us to continue to work on the First Application 9/851/2011 state. Utilizing the same personnel makes the transition smooth. We are migrating some state accounts to be FirstNet accounts/devices to test the billing and process. We will wait another month for most agencies as billing process is not correct yet (not all services migrated, additional fees, taxes etc.). Our governance council (SD Public Safety Communications Council) met and we had good discussion on FirstNet with AT&T helping to answer questions. The council is considering to bring in political candidates to discuss public safety communications at their next meeting. Set up a meeting with Zuercher Technologies (www.zuerchertech.com) in April to discuss how they fit in with FirstNet, interoperability between systems (departments) within South Dakota and any possibility of centralizing their CAD system in/for SD etc. Their CAD system is used in the majority of agencies in South Dakota. Our project manager attended the International Wireless Communications Expo (IWCE 2018) to attend the FirstNet tracks, and meet with VP's of AT&T/FirstNet. He was invited to be a part of a VIP focus group at the IWCE conference. It was setup as a roundtable discussion to improve FirstNet's understanding of the needs and expectations of FirstNet. AT&T and we presented to Brown County & City of Aberdeen for discussion on FirstNet and how it relates to state radio, and state public safety communications. They use AT&T, Verizon, and Valley Telco LTE (A local Telco in the county) – which is a good example of what is out there today and the need for interoperability between carriers (national and local). Shared time with Department of Public Safety deputy director and presented to the County Commissioners Association to answer many questions about both FirstNet and Statewide Radio system. We were contacted by AT&T marketing team looking to utilize an incident that underscores the importance of priority and preemption in rural communities to enhance public safety. We continue to inform our stakeholders through social media as appropriate. Still waiting for AT&T to get us a userid/pw to the portal to track the FirstNet accounts, as now all responsibility for this work lands on a BIT employee. We have a challenge understanding where the FirstNet Authority fits in the picture with the states. We've been working directly with AT&T for the past year and now FirstNet Authority wants to re-engage and we are confused. We'd like to have more information on the interoperability plans of FirstNet. Today the only interoperability on this LTE network is if we know everyone's cell phone number. There is no single app (mobile application) that pulls in all the FirstNet users in an interoperable fashion. If we don't solve this sooner rather than later we will have fragmented pockets of all kinds of disparate applications and none will be interoperable and it will set the public safety industry back 20 years. In the next quarter we plan to attend the 2018 Public Safety Communications Research Stakeholders annual meeting in San Diego. We will attend and present at the SD Police Chiefs & Sheriffs annual joint meeting. We will continue to attend/convene FirstNet-requested public safety stakeholder outreach meetings focused on various topics. Any additional project milestones or information: We have tested moving a few state agency accounts to migrate those on AT&T commercial network over to the FirstNet system. At this point it is simply a rate plan change over, and AT&T is trying to get all the billing correct. These devices will need to get the FirstNet Sim cards when the core is built and AT&T provides them. Other allowable activities performed this quarter include: Further Identification of Potential Public Safety Users
