During Quarter 8, The TACN team additionally continued visiting agencies in the 15 most distressed counties to discuss public safety communications and assess the needs of these counties. Topics discussed are the TACN P25 system, FirstNet and it's capabilities and the Critical Connect platform that will provide LMR -> LTE via FirstNet. The team met with Morgan County Sheriff Wayne Potter , Fentress County Sheriff Michael Reagon, Cocke County Sheriff Armando Fontes, Hancock County Sheriff Bradley Brewer, Perry County Sheriff Nick Weems and Clay County Sheriff Brandon Boone. Although SLIGP dollars are not used, we maintain a monthly meeting with representatives from FirstNet/AT&T to keep apprised of completed and future coverage enhancements. This quarter's TACN AP meeting continued the discussion of the LMR -> LTE solutions, use cases, and potential impact on rural areas.
